




Other real estate activity guidelines in Phase 2 by 99.co

There's more to Covid-19 safe management guidelines than just property viewing. We summarise the key ones:

- No in-person property seminars and training sessions.
- Property agents and assigned vendors may enter properties to photograph and film the premises for marketing purposes. The same safe management guidelines (e.g. maximum group of five, contact tracing records) apply.
- Continue to defer all door-to-door and face-to-face marketing activities.
- Client visits to real estate offices should only occur where wet-ink signatures are required. The same safe management guidelines apply.
- Agent can be present during takeovers/handovers, but it should be kept to a single meeting with minimal interaction. The same safe management guidelines apply.
- Use IT tools whenever possible.
